WBC Privacy policy

This privacy policy applies between you, the User of this Website and WBC, the owner and provider of this Website. WBC takes the privacy of your information very seriously. Definitions and interpretation

1. In this privacy policy, the following definitions are used:

Data: Collectively all information that you submit to WBC via the Website. This definition incorporates, where applicable, the definitions provided in the Data Protection Laws;

Data Protection Laws: any applicable law relating to the processing of personal Data, including but not limited to the Directive 96/46/EC (Data Protection Directive) or the GDPR, and any national implementing laws, regulations and secondary legislation, for as long as the GDPR is effective in the UK;

GDPR: the General Data Protection Regulation (EU) 2016/679;

WBC, we or us

 - C. a reference to a person includes firms, companies, government entities, trusts and partnerships;
 - D. "including" is understood to mean "including without limitation";

Scope of this privacy policy

- This privacy policy applies only to the actions of WBC and Users with respect

How we collect Data

Data that is given to us by you

Keeping Data secure

 - B. we store your Data on secure servers.

Data retention

Your rights

- 17. You have the following rights in relation to your Data:
 - A. **Right to access** the right to request (i) copies of the information we hold about you at any time, or (ii) that we modify, update or delete such information. If we provide you with access to the information we hold about you, we will not charge you for this, unless your request is "manifestly unfounded or excessive." Where we are legally permitted to do so, we may refuse your request. If we refuse your request, we will tell you the reasons why.
 - B. **Right to correct** the right to have your Data rectified if it is inaccurate or incomplete.
 - C. **Right to erase -** the right to request that we delete or remove your Data from our systems.
 - D. Right to restrict our use of your Data the right to "block" us from using your Data or limit the way in which we can use it.
 - E. **Right to data portability -** the right to request that we move, copy or transfer your Data.
 - F. **Right to object -** the right to object to our use of your Data including where we use it for our legitimate interests.

If any court or competent authority finds that any provision of this privacy policy (or part of any provision) is invalid, illegal or unenforceable, that provision or part-provision will, to the extent required, be deemed to be deleted, and the validity and enforceability of the other provisions of this privacy policy will not be affected.
- 27. Unless otherwise agreed, no delay, act or omission by a party in exercising any right or

Unless otherwise agreed, no delay, act or omission by a party in exercising any right or remedy will be deemed a waiver of that, or any other, right or remedy.

28. This Agreement will be governed by and interpreted according to the law of England and Wales. All disputes arising under the Agreement will be subject to the exclusive jurisdiction of the English and Welsh court.

29. WBC reserves the right to change this privacy policy as we may deem necessary from time to time or as may be required by law.
